### **Executive Summary**

The Integrated Care Boards (Establishment) Order 2022 made by NHS England took effect on 1 July 2022. The establishment order also brought into effect the ICB's constitution (and standing orders).

On Friday 26 July 2024 NHS England <u>published updated governance guidance for ICBs</u> to take account of wider legislative developments and issues that have arisen in implementation to ensure that governance arrangements remain fit for purpose and all ICBs are being requested to update their constitution and associated governance handbook to accommodate these changes.

Amendments are required to ICB constitutions at the earliest opportunity for the following specific reasons which are detailed in this report and are highlighted for ease in the appended constitution so that Board members can be assured that these iterations have been undertaken.

For further assurance the Audit and Risk Committee received this paper on 27 August 2024, and through the Audit and Risk Chairs report are supporting recommendation of approval of the highlighted amendments to Board.

# NHS Buckinghamshire, Oxfordshire and Berkshire West ICB Constitution

#### 1. Introduction and Context

- 1.1 The Integrated Care Boards (Establishment) Order 2022 made by NHS England took effect on 1 July 2022. The establishment order also brought into effect the ICB's constitution (and standing orders).
- 1.2 On Friday 26 July 2024 NHS England published <u>updated governance guidance</u> for ICBs to take account of wider legislative developments and issues that have arisen in implementation to ensure that governance arrangements remain fit for purpose and all ICBs are being requested to update their constitution in line with section 1.6.1 (b) of BOB ICB Constitution 'Variation of this constitution'. The governance guidance has been published to address the following:
  - ✓ A ministerial commitment to Parliament that NHS England would issue guidance to ICBs meeting their statutory duty to keep under review the skills, knowledge and experience of their Board
  - ✓ The section on managing conflicts of interest takes into account the introduction of the Provider Selection Regime
  - ✓ A section more clearly setting out the alternatives for ICBs to delegate their statutory functions to other bodies
  - ✓ Recognising the importance of executive leadership on supporting care leavers (not a new role but emphasising it is part of safeguarding leadership responsibilities).
- 1.3 Amendments are required to ICB constitutions at the earliest opportunity for the following specific reasons detailed below and which are highlighted for ease.
- 1.4 The proposed changes to the constitution can be <u>viewed here</u>. It is not appended in full to this report, in order to minimise the volume of papers; references to the appropriate sections are set out below for ease of reference.
